Oasis Bradford Treatment Contract

- 1. I, the client, agree to take my medication as prescribed to me by the Doctors or authorised members of their medical team. This is to ensure that Oasis Bradford may fully comply with medical duty of care guidelines during the detox.
- 2. I agree that Oasis Bradford will hold and administer my medications as prescribed by my GP and the Oasis Bradford doctor.
- 3. I agree to comply with the Therapeutic Programme and engage with the treatment offered at Oasis Bradford.
- 4. I agree to not discuss my individual detox medication with fellow clients.
- 5. I agree to abstain from using any form of mind or mood alerting substance including alcohol. This includes medication that has not been prescribed or sanctioned by Oasis Bradford Doctors or authorised members of their medical team.
- 6. I agree not to mix, associate or spend time in the company of anyone who uses any form of mind or mood altering substance.
- 7. I agree to not enter into any form of illegal activity whilst I am resident at Oasis Bradford.
- 8. I agree to not enter any other bedroom at the Centre, at any time, except for the bedroom allocated to me for my stay. Also to not let others into my bedroom.
- 9. I agree to be appropriately dressed at all times during my stay at Oasis Bradford.
- 10. I agree to remain within the Centre unless given permission from, and being accompanied by, a designated member of Oasis Bradford staff.
- 11. I agree to refrain from using any form of violent or threatening behaviour to peers, staff, visitors, property or members of the community. Anyone who commits a violent act will be reported to the police and charges pursued.
- 12. I agree to abide with the no smoking policy and to use only the designated smoking areas should I choose to smoke.

- 13. I agree to not discriminate against any person at Oasis Bradford. This includes discrimination in relation to age, gender, sexuality, colour, creed, size, religion or social standing.
- 14. I agree to take part in random drug tests as and when requested to do so, or as directed by the courts or probation services. A positive result or adulterated tests may result in instant discharge from treatment.

 Refusal to provide a sample may also lead to discharge from treatment.
- 15. I agree that I will not form any exclusive relationships with fellow clients during my stay.
- 16. I agree to behave in a respectful, tolerant and caring manner towards peers, Oasis Bradford staff, neighbours, and the community at large.
- 17. I agree to room and belonging searches being carried out whilst in treatment.
- 18. I agree to keep my bedroom tidy and not to damage it in any way. (I will report any breakages or accidents immediately)
- 19. I will not offer medication that has been prescribed to me to any other patient at Oasis Bradford.
- 20. I understand that Oasis Bradford has a zero tolerance policy towards violence and any such behaviour may result in the authorities being notified.
- 21. I will attend three meals per day with the community.
- 22. I will maintain a socially acceptable level of personal hygiene and appearance.
- 23. I will allow Oasis Bradford staff to store any cash, credit cards and car keys I may have in a locked cupboard for safety.
- 24. I will agree to abide by the no visits for the first seven days in treatment policy.
- 25. I will maintain an attitude of willingness to get well and show respect and consideration for others whilst at Oasis Bradford.
- 26. I understand that all gambling is forbidden at Oasis Bradford.
